#### **BUILDING TRADES**

Project Labor Agreements are comprehensive agreements between a municipality and/or developer and a jurisdictional Building Trades Council that set requirements for a building project. PLAs save money by guaranteeing no strikes or picketing, that correct wages are paid, and that unscrupulous contractors won't victimize the project. PLA projects guarantee unions will work together so the project is of higher quality, are usually finished on or before schedule, use community labor and are often below budget.
